- Students may participate in a team consisting of not more than 2 persons.
- No restriction on the number of entries from any one college or university.

REGISTRATION

- No prior registration is required.

- Each team can submit only 1 poster.
- A valid identity proof of college/university must be attached with an entry.
- Participants must send their entries via Google form on or before 25th January 2021.
- The poster must be made on the A3/A4 size sheet with margins drawn with black ink.
- Photographs, 3D objects, print-outs won't be acceptable.
- It should be an original and hand done work.
- Name and class of study of the participant along with college/university name must be clearly mentioned on the sheet.
