

## **Notice Regarding Screening Test for Migration to 2nd Year of B.A.LL.B. (Hons.) at UILS – 2021-22**

This is for the information of all the candidates who applied for migration to 3<sup>rd</sup> semester of B.A.LL.B. (Hons.) at UILS 2021-22. That as per the direction dated 25.02.2022 by Hon'ble High Court of Punjab & Haryana in CWP No. 1952 of 2022, the Worthy Vice-Chancellor has allowed to conduct **Screening Test** for the above mentioned purpose, which will be conducted as per below:

**Date of Screening Test: 23.04.2022 (Saturday)**

**Time of Screening Test: 10.00 a.m.**

**Venue: University Institute of Legal Studies,  
Panjab University, Sector-14, Chandigarh**

Only the candidates who applied for migration between 1<sup>st</sup> to 7<sup>th</sup> September, 2021 and were found eligible for migration as per the notice displayed on UILS's website on 14.12.2021, can **apply for Screening Test** as per below:

1. Fill the online registration form available at <https://forms.gle/DegsYu52ydHNrxsN6>
2. Take the print out of registration form available at last page of this notice, fill it up in your own handwriting.
3. Prepare the Demand Draft of **Rs. 2000/-** from any bank in favor of **Chief Coordinator, UIAMS (Exams) P.U., Chandigarh** and submit it in the office of UILS **on all working days till 4.00 p.m. upto 18.04.2022** along with Registration Form mentioned at point 2.
4. The candidates are also advised to bring one **Photostat** copy of registration form and demand draft.

### **Important Note:**

- Only the candidates who applied for migration earlier can apply for registration of Screening Test. No fresh application/s will be accepted.
- If any candidate fails to submit Demand Draft of required fee and registration form as per the schedule mentioned above **will not be allowed** to appear for Screening Test.
- **Admit Cards** for Screening Test will be issued to students on their respective **email addresses upto 21.04.2022**.
- Date of Result Declaration: **26.04.2022 (Evening)**.
- The applicants are directed to **reach** the venue of test before **Two Hours** of test timing.
- The candidates who achieve **45% or above marks** in the screening test will be considered for migration as per the **merit list** prepared on the basis of screening test result.

### **Structure for the Question Paper will be is as under:**

a) There will be one subjective type question paper of two hours durations with maximum marks as 120, comprising a total of 12 questions divided into six sections, each having two questions with medium of examination as English. The candidates will have to attempt six questions in all selecting one from each Section. Each question will carry 20 marks.

b) The six sections will be:

Section-1: English-I/ English-II

Section-II: History-I/History-II.

Section-III: Political Science-1/Political Science-II

Section-IV: Sociology-1/Sociology-II

Section-V: Law of Torts including Motor Vehicle Accident Act and Consumer Protection Law/ Jurisprudence

Section-VI: Law of Contract/ Special Contract

c) Each Section will have two questions and further each question will have two parts (a) & (b)-part-(a) from Semester-1 and part-(b) from Semester-II from the **syllabus** taught during the academic session **2020-21** as available on P.U.'s website i.e. <https://puchd.ac.in/syllabus.php?qstrfacid=7>

d) The candidate will get **20 minutes** to attempt both Parts-A & B of a question.


