Modes of Fee Payment

<u>Important:</u>

- Regarding any information about fee concession/refund rules, the students are advised to check Panjab University Handbook of Information-2023 available at <u>https://puchd.ac.in/importantdocuments.php</u>
- The students who will be paying fee through online mode, required to submit **copy of Online Fee Payment** to their respective dealing official in the office of UILS as per the dates mentioned above. **Failure** to which, student will be treated under **NON PAYMENT OF FEE** and his/her name will be **struck off** from the department.
- Each student is required to pay above mentioned tuition fee as per the prescribed schedule. Students who are absent, or on leave, on the prescribed dates will arrange to deposit their dues for the 2nd installment through someone. The names of such students who will not deposit 2nd installment of tuition and other fees shall be struck off the rolls of the Department w.e.f. **1st January 2024** and shall not be allowed to attend the classes. Students whose names have been struck-off for

non-payment of dues for the 2nd installment can seek re-admission between 1st to 31st January, 2024 through the Chairperson/ Head of the Department concerned. After the lapse of this period, re-admission would be granted by the D.U.I. only in very hard and genuine cases.
