The Competition seeks to provide a platform to the brilliant and ardent legal minds of the institutions to have a pragmatic insight into the working of the law making machinery of our country and augment their legislative drafting and law interpretation skills.

Through this competition, the cell seeks to promote the participation of the students in the political processes and functioning of democracy by drafting laws on contemporary issues that are yet to be deliberated by the Legislature. The competition seeks to provide a platform for the exchange of ideas and experience. This competitions would serve as an academic stimulation and harness skills like drafting, critical thinking, writing skills and teamwork, making them better professionals

Under the same program, the CJPC team organized A National Webinar on "Making of Law" aimed at explaining the processes involved in enactment of a law by the parliament of India by Honorable N.K. Premachandran, Member of Parliament, Lok Sabha on 3rd May 2020.

The webinar encompassed a detailed insight into the legislative processes involved in enactment of a Law in India including drafting, presentation of a bill, references made to parliamentary committee, parliamentary debate and discussion, inclusion of suggested amendments and voting in both the houses of parliament and thereafter sending the passed bill for presidential approval and implementation.

LEGISLATION DRAFTING COMPETITION

ELIGIBILTY:

The competition is open to all the students pursuing a 3year/5year degree in Law.

REGISTRATION:

The registration form is annexed in the end. The registration fee for the competition is INR 300/- per participant/team. The amount shall be forwarded via bank transfer. There shall be a team cap of 50 teams and selection shall be on first come first served basis. Students interested are required to send the duly completed registration form to <code>lawdraftingcjpc@gmail.com</code> along with a scanned copy of their College-id and receipt of payment to be made latest by 14thMay 2020 at 18:00 hrs. All these formalities must be completed in order to confirm the participation.

TEAM COMPOSITION:

The person may participate individually or in a team which may comprise of maximum 2 members.

- There is no limit on the number of teams participating from a single institution.
- The members of a team shall belong to the same institution. Under no circumstances shall an individual be allowed to represent an institution which he is not a part of.
- The participating students are required to provide their identity cards to the organizing committee along with their registration form. Failure to do so shall result in disqualification.

FORMAT OF THE SUBMISSION:

- All the teams must send electronic copies of their legislative draft in "pdf" format via email at *lawdraftingcjpc@gmail.com*.
- The language of the competition shall strictly be English.
- The bill shall be typed on A4-sized paper.
- The font of the write up must be Times New Roman, Size 12, 1.5 line spacing and 1 cm margin on each side.
- The citation methodology to be followed is Harvard Bluebook (19th Edition).
- The font of footnotes must be Times New Roman, Size 10, single line spacing.
- Page numbers must be given at the bottom right hand corner.
- The length of the bill should not exceed 20 pages.
- The cover page of the submission should include the Long Title of the bill along with the team code.
- Plagiarism count of more than 20% shall be considered as a ground for disqualification.

- The Preamble
- The Enacting Clause
- The Short Title
- Extent and Commencement Clause
- Definitions
- The Operative Section
- Exceptions and Exemptions Clause (if any)

The draft bill shall be succeeded by a "Statement of Object and Reasons" (maximum 2 pages).

DRAFT MARKING CRITERIA:

Award of the points shall be based on the following parameters:

- Neatness, no typographical errors or format errors
- Logical progression of ideas
- Effective use of headings
- Understanding essential legal issues presented
- Focus on essential (not collateral) issues
- Clear, concise and unambiguous writing style
- Forceful and persuasive presentation
- Ability to distinguish adverse cases

PROCEDURE:

- 1. The competition shall begin with the release of a topic on 15th May 2020.
- 2. There shall be a team cap of 50 teams. A maximum of 2 students would be allowed per team.
- 3. Teams shall be given a time period of 15 days to draft their legislations.
- 4. Submission of the draft has to be made strictly in adherence to the specified date and time. For any subsequent delay, 1 mark shall be deducted for every two hours.
- 5. The last date for late submission of the legislation shall not exceed two days under any circumstance.
- 6. The final draft of the legislation should be mailed at lawdraftingcjpc@gmail.com.
- 7. The teams shall receive the confirmation of draft submission within 24-48 hours.

8. After the declaration of results, all the entries received, i.e., 50 drafts would be uploaded to the cloud and a link would be provided to all the teams.

AWARDS:

- **Best Team** with a cash prize of INR <u>7,500/-</u> and a Certificate of Merit.
- First Runners up Team with a cash prize of INR <u>3,500/-</u> and a Certificate of Merit.
- **Second Runners up Team** with a cash prize of INR 1,500/- and a Certificate of Merit.
- All the participants shall be awarded with a Certificate of Participation.
