If, I fail to fulfill this statutory requirement, I shall have no right to appear in the examination for the relevant semester/course.

That I am aware of the Rule passed by the Syndicate which provides that promotion/admission to 2nd year (3rd semester) or 3rd year (5th Semester) or 4th year (7th semester) or 5th year (9th semester) shall be allowed if I have passed at least 50% of the papers of the previous semesters, as the case may be.

In the month of November odd semester examinations (regular and reappear) i.e. 1st, 3rd, 5th, 7th and 9th semesters shall be held and in the month of May even semester examinations (regular and reappear) i.e. 2nd, 4th, 6th, 8th and 10th semesters shall be held. However, students having reappear in 9th semester shall be allowed to take up the reappear examination in the month of May alongwith 10th Semester.
