1. **Ist demand draft of Rs. 58690/-** (candidates who have passed qualifying examination from Panjab University) and **Rs. 59690/-** (candidates who have passed qualifying examination other than Panjab University).
Demand Draft be prepared in favour of **Registrar, Panjab University, Chandigarh.**
2. **IInd demand draft of Rs. 26600/-** as department funds to be paid by all selected candidates.
Demand Draft be prepared in favour of **Director, UILS, Panjab University, Chandigarh.**
3. **IIIrd demand draft of Rs. 5000/-** as library security (refundable at the end of the course) to be paid by all selected candidates.
