- As per the instructions by the competent authority, these candidates will have to pay **late fee of Rs. 1000/-**. This fee can be paid by adding with amount of **University Fee** i.e. needs to pay **67220/-** (candidates who have passed qualifying examination from Panjab University) and **Rs. 68220/-** (candidates who have passed qualifying examination from other than Panjab University).
- The candidates who are paying fee in the form of demand drafts, can deposit the **demand drafts, below mentioned documents and undertakings** by hand in the office of UILS, Panjab University, Sector-14, Chandigarh on **17.10.2022 (Upto 4.45 pm.** except lunch break i.e. 1.30 pm to 2.30 pm) and **20.10.2022 (9.30 a.m. to 4.45 p.m.** (except lunch break i.e. 1.30 pm to 2.30 pm).
- It is mandatory for the candidates who are paying fee through online mode to provide the copies of the **fee receipt, transaction** details with the **documents and undertakings** in the office of UILS, Panjab University, Sector-14, Chandigarh on **17.10.2022 (Upto 4.45 pm** except lunch break i.e. 1.30 pm to 2.30 pm) and **20.10.2022 (9.30 a.m. to 4.45 p.m.** (except lunch break i.e. 1.30 pm to 2.30 pm).
