- The candidates who want to pay fee in the form of demand drafts, can deposit the demand drafts and undertakings by hand in the office of UILS, Panjab University, Sector-14, Chandigarh from **9.30 a.m. to 4.45 p.m.** (except lunch break i.e. 1.30 pm to 2.30 pm) on **20th September, 2023**.
- It is mandatory for the candidates who will pay fee through online mode to submit the copies of the fee receipt and transaction (in case of online payment) details along with the undertakings by hand in the office of UILS, Panjab University, Sector-14, Chandigarh from **9.30 a.m. to 4.45 p.m.** (except lunch break i.e. 1.30 pm to 2.30 pm) on **20th September, 2023**.

- In case any candidate fails to pay the fee and submit the details of the same as per above mentioned instructions, the seat will be declared vacant and passed on to candidate in waiting.

Important Note:

- Admission of provisionally selected candidates will be subject to the verification of **Original Documents**.
- The candidates who had taken admission to **LL.M. (1 Year) and Master of Law (2 Years) Course** during the counsellings and also paid the fee, now have been selected for other course i.e. from **Master of Law (2 Years)** to **LL.M. (1 Year)** and **vice-versa**, they need to fill **Undertaking for Shifting of Course** available at Admission Notices along with other Undertakings Regarding Admission.
- In case any candidate fails to pay the fee or provide the detail of fee and does not submit the required original documents as mentioned above, the seat will be declared vacant and passed on to next candidate in waiting.
